Meeting of the Council Held in the Devonshire Rooms 7 January 1896 At 7pm

Mr Cornell presided and there were also present Messrs. Deacons, Brazier, Fowle, Hollands, Kemsley, Burke, Beadle, Hawks and Dr Gash.

Minutes

The minutes of the last meeting were read and confirmed.

Correspondence

- 3 Letters from the Home Secretary.
 - 1 Re Ministers Fees
 - 2. Acknowledging receipt of Rules regulations and Scales of fees.
 - 3. Stating that he wished to approve of fees only and suggesting addition of words "or child not a month old" after words "still born child" in Rule 3.

Mr Deacons proposed and Mr Beadle seconded that the Scale of fees be sent back to the Home Office without the addition of the words to Rule 3.

Mr Burke moved all amendments that the Clerk ask the Home Secretary to define the meaning of his suggestion. Mr Fowle seconded Messrs Kemsley, Burke Fowle and Dr Gash voted for the amendment and Messrs Brazier, Beadle, Hawks, Deacon, Hollands against it and it was declared lost.

The original motion was thus dec[lare]d and carried. Messrs Kemsley and Burke alone voting against it.

Barrow on Soar

Post Card – to Barrow on Soar agreement the Clerk stated he had sent for 2 copies of Parish Council's journal which contained the whole text.

Waghorn Road

Four letters from property owners in Waghorn Road: re repairs.

Mr Hawks stated he was willing to bear his share of expense.

3 owners had now answered.

The matter was left in hands of chairman for an estimate of cost.

Mavs Portrait

Letter from Mr Bateman. Stating that H Wood Esq of Chatham had a portrait of John May Esq., benefactor to Snodland. M Wood offered to present the portrait to the Parish Council.

Mr Beadle proposed and Mr Deacon seconded that the Clerk put himself in communication with Mr Wood and to convey the thanks of the Council to Mr Bateman. Carried.

Reports

Mr Deacon reported what had been done in reference to Great Coats. A letter had been received from the firm who has hitherto supplied the coats asking for instructions and this had been send on to Mr Roberts.

The Chairman made a statement respecting the work of Bridge Committee. An exhibition of the designs would be made in the room above on the 13th and 14th inst.

<u>Deputation of Rector</u>

Mr Deacons reported the result of the deputation to the Rector. The Rector was asked to forego all the fees, and accept an agreement on the lines of the Barrow on Soar agreement. He stated he was willing forego all the fees, accept the 2/6 fee for interments on the consecrated ground by whomsoever performed. He was willing to forego this fee in the case of a non conformist who may have a relative buried in the consecrated portion and whose friends wish to lay him or her in the same grave as, or near at hand to the grave of such relative. These concessions would have no binding force on his successor.

Mr Deacons suggested that an agreement be made on these conditions and steps at once taken to have the ground consecrated.

Mr Fowle proposed and Mr Deacon seconded that the arrangement be accepted as suggested so the Rector's letter carried.

Mr Deacon proposed that the Rector be asked at once to have the ground consecrated on the understanding that a legal document be drawn up and signed by the Council, Bishop and Rector. This was seconded by Mr Hawks, and carried Messrs Kemsley and Burke voting against and lost. Mr Hollands remaining neutral.

Mr Beadle proposed and Mr Brazier seconded that the drafting of the deed be left with the deputation Messrs Cornell, Deacon and Hodgkinson carried.

Messrs Kemsley and Burke voted against it and Messrs Deacon, Brazier, Fowle, Gash, Beadle, Hollands and Hawks for it.

Caretaker of Cemetery

Mr Beadle proposed and Mr Deacon seconded that the whole Council form itself into Committee in order to discuss the appointment of Caretaker of the Cemetery.

Mr Deacon in voting a resolution said that during 5 months of summer he would find work enough in the cemetery 2 months he would find only partial employment and

nothing the five winter months. During this time he might be able to do the work on the Brook and other work the Council might wish done.

Mr Deacon proposed and Mr Brazier seconded that this Council engage a man to do all work required to be done at the cemetery and all work required to be done on the Brook and any other work the Council may require to be done in the Parish of Snodland.

That this Council offer 18/- per week wages house and water free.

That notice be posted on the Council's notice boards inviting applications for the situation. Applicants must reside in Snodland, Birling or Halling.

Applications must be made in own hand writing and left with the Clerk to the Council, with two testimonials on or before ..

Any candidate canvassing the members of the Parish Council will be disqualified.

Mr Fowle moved an amendment that when the caretaker is appointed his work shall be confined to the Cemetery and that the wage be £1 with house and water. This was seconded by Mr Kemsley.

After a good deal of discussion Mr Kemsley proposed that the meeting be adjourned till Wednesday the 15th next at 7pm.

This was seconded by Mr Hawks and carried only Messrs Beadle and Brazier voting against it.

Accounts

Mr Hodgkinson's for use of British School Room for meetings.

Mr Fowle proposed and Mr Kemsley seconded that a cheque for £2.12.0 be drawn to pay this account. Carried.

Mr Langridge's for work done in cemetery buildings.

Mr Beadle proposed and Mr Burke seconded that a cheque for £500 be drawn to pay the account. Carried.

Mr Milford's account for fence at Cemetery, balance of account.

Mr Kemsley proposed and Mr Holland's seconded that a cheque for £18 be drawn to pay this account. Carried.

The Gas a/c for quarter ended Xmas.

Mr Deacon proposed and Mr Brazier seconded that a cheque for £31-17-6 be drawn to pay this account. Carried.

Mr H Draycon's a/c repair for lamps.

Mr Burke proposed and Mr Deacon seconded that a cheque for £2-6-11 be drawn to pay this account. Carried.

Draft of Agreement with Mr S Lilibourne

Mr Hollands read the draft agreement between the Snodland and Birling Councils and Mr Stephen Lilibourne – re Godden's Charity land at lvychurch. The draft was approved, and the Clerk was instructed to send it on to Birling Council for their approval.

Mr Burke proposed and Mr Kemsley seconded and it was resolved that the best thanks of the Council be given to Mr Hollands for the trouble he had taken over the preparation of this deed.

A plan of the Cemetery with the grave spaces marked thereon was submitted to the Council.

The Chairman suggested that the outside spaces be included in Class A, the next two in Class B and all the rest in Class C, a space in each section being reserved for Childrens' grave spaces.

Mr Deacon proposed and Mr Kemsley seconded that a Committee of 5 be appointed to decide on the different Classes &c.. Carried.

Mr Hawks proposed and Mr Hollands seconded and it was resolved that Messrs Kemsley, Deacon, Fowle, Burke and Brazier form the Committee.

Signed Geo. Corney Jay 28 1896

Adjourned Committee Meeting held in the Devonshire Rooms January 15th 1896

Mr Corney in the Chair, and there also present Messrs. Deacon, Hollands, Burke, Fowle, Hodgkinson, Archer, Brazier, Hawks, Gash and Beadle.

Mr Deacon withdrew his resolution and Mr Fowle his amendment to that resolution leaving the Councillors free to discuss the whole question.

After a long and exhaustive discussion Mr Burke proposed and Mr Deacon seconded that a Caretaker for the new Cemetery be appointed. Carried.

Duties, Salary etc.

Mr Burke proposed and Mr Fowle seconded that it shall be the duty of the Caretaker, when appointed, to dig the graves, do the planting, keep in good preservation all flowers, shrubs, plants, walks and pathways, and to perform any other duties connected therewith:- and further the Council or Board shall have the power to put him to any other employment over which they may have control; and for such work and duties he shall be provided with a house to live in, and shall receive as wages 24/- per week. And in the event of the caretaker wishing to resign, or that the Council or Board may wish him to resign, one month's notice shall be given in each case.

Mr Deacon moved an amendment that it shall be the duty of the Caretaker when appointed to dig and fill in graves, do the planting, keep in good preservation all flowers, shrubs, plants walks and footways and to perform any duties connected forthwith:- and further the Council or Board shall have power to put him to any other employment over which they may have control, and for such work and duties he shall be provided with a house and water free and shall be paid as wages 21/- per week providing always that such engagement be terminated by a month's notice on either side.

This was seconded by Mr Hodgkinson and carried by 7 to 3.

On its becoming the substantive motion Mr Burke moved an amendment that the words "and further the Council or Board shall have the power to put him to any other employment over which they may have control" shall be taken from the resolution. This was seconded by Mr Fowle and lost by 7 to 3.

The substantive motion was then put and carried.

The Clerk was instruction to post a notice inviting applications for the office of Caretaker from the Parishioners of Snodland, Birling and Halling.

Geo Corney Jay 28 1896

Parish Council Meeting held in the Devonshire Rooms on Tuesday January 28th 1895 at 7pm

Mr G Corney presided and there were also present Councillors Hollands, Deacon, Brazier, Beadle, Burke, Fowle, Kemsley, Archer and Hawks.

Minutes

The Minutes of the last meeting, and adjourned Committee meeting were read and confirmed.

Reports of Committees

Fire Extinguishing

Mr Brazier read the report of "Fire extinguishing" Committee.

It recommended set of hydrants for the inhabited part of the Parish (22) with two set of hose. 7 hydrants were already down and the cost of 15 more would be included appliances £114-16-0.

The hose and other appliances to be kept in two sheds, one in High Street, near the Water Co's Office. And one at or near the Institute. They recommended the work to be carried out in two years: the first year 4 hydrants and all appliances to be provided at an estimated cost of £57-16-0 and the 11 hydrants in the second year.

Mr Brazier proposed and Mr Deacon seconded that the report be adopted and recommended for the Parish meeting. Carried by 6 to 2 Messrs Kemsley and Burke voting against and Messrs Deacon, Brazier, Beadle, Archer, Hollands and Fowle for it.

Cemetery Committee

The Chairman reported that the Committee had decided to recommend that Class A shall extend along either side of the centre path one space deep. Class B to comprise the whole of the second space on either side of the centre path and the two outside spaces on either of the outside paths: 81 spaces in each section to be reserved for childrens' grave spaces and the rest of the spaces to form Class C as marked on the plan.

Mr Burke proposed that the report be adopted, and Mr Kemsley seconded and it was carried.

Correspondence

Letter from H Wood Esq., re John May's portrait. He promised to present the portrait to the Parish Council as soon as renovated.

Letter from Secretary of State acknowledging receipt of Scale of Fees and charges.

Letter from Mr Prosser re May's and Godden's Charity Trustees. The Clerk was instructed to send names of Trustees.

Letter from Messrs Peters Bros. Asking permission to lay a tramway from their property adjoining the churchyard to the Railway. The Clerk was instructed to state that the Council had no objection but suggested that as the road was private, application should be made to the property owners and the path being under the control of the District Council, application should be made to that body.

Lighting Account

The lighting account having been audited by Messrs Archer and Beadle was approved and adopted by the whole Council.

Jubilee Account

Mr Deacon stated that a balance of about £6 was left over from the Jubilee Fund in the hands of the Rev. J L Bingley. He gave notice that he would bring the matter on for discussion at the next meeting.

Committee to Open Applications for Caretaker

Mr Deacon proposed and Mr Hollands seconded that the whole Council resolve itself into Committee to discuss the applications for Caretaker to the Cemetery. Carried.

The public having retired the following applications were opened by the Chairman.

Mr Beadle proposed that three applications be invited to meet the Council and that the three names be balloted for. This was seconded by Mr Deacon and carried.

Birling Road, Snodland

The ballot resulted in the return of Messrs. Fletcher, Knell and Gooding.

Mr Deacon proposed that Messrs. Fletcher, Knell and Gooding be invited to meet the Council on Tuesday next at 8pm and that this meeting be adjourned till Tuesday next at 7.30. This was seconded Mr Burke and carried unanimously.

Geo. Corney Feby 11 1896

Parish Council Meeting held in The Devonshire Rooms on Tuesday Feby 11th 1896 at 8 p.m

Mr Geo. Corney presided and there were also present Messrs. Brazier, Beadle, Deacon, Archer, Burke, Kemsley and Fowle and Hodgkinson.

Brook Report

7. Thomas Hards

Mr Deacon proposed and Mr Brazier seconded and it was resolved to draw a cheque for £5 to pay the wages of the man working on the Brook.

Mr Deacon reported that there was a large hole on the Brook caused by the washing of the tide.

He proposed that some piles be drawn and the hole filled up with earth Mr Brazier seconded and it was carried.

He also stated that a trunk had been damaged but suggested it be left over that the exact amount of damage might be estimated.

He reported also that he had been unable to obtain any further information with respect to the piece of land on Ham Hill Brook which is supposed to belong to the Parish of Snodland.

The ditch between the allotment and Ham Hill Brook required cleaning and to prevent cattle straying into the allotments.

Mr Burke proposed and Mr Kemsley seconded that the matter stand over to enable the Committee to ascertain the cost of a fence and the cleaning out of the ditch. Carried.

Part of the ditch by Andrews' allotment had been filled in, and if the land was to be held as a garden a fence must be put up. One of three things migh be done. 1. Fence in garden only. 2. Include it in the Brook. 3. Fence in part of the Brook, south of the road question left over.

Report of Cemetery Committee

Mr Deacon proposed and Mr Kemsley seconded that the 6 dead trees be not replaced till November next. Carried.

Mr Beadle proposed that the Caretaker be allowed to have a piece of land 4 yds wide at the west end of the appropriated portion of Cemetery as a garden partly for his own use and partly for the raising of flowers and shrubs to be used in the Cemetery. Mr Hodgkinson seconded and it was carried.

Mr Burke proposed that the Council purchase a one man roller – double cylinder. This was seconded by Mr Deacon and carried.

Mr Hodgkinson proposed that a small portion of the Cemetery adjoining the house be fenced off for the private use of the Caretaker. This was seconded by Mr Beadle and carried.

Mr Deacon proposed that the road just inside the Cemetery, which Mr Bensted had arranged to be altered remain as it is, and that the Clerk be instructed to write to him, informing him of the Council's decision. This was seconded by Mr Archer and carried.

Mr Fowle proposed that an iron unclimbable fence be placed on the east side of the Cemetery between the Cemetery buildings and the end of the stake fence – about 73 yards. No seconder.

Mr Beadle proposed that the matter be left over till all the contract work had been completed, paid for and in the meantime, the Caretaker be instructed to borrow some hurdle gates to put along the space from Mr Champion. This was seconded by Mr Deacon and carried.

Correspondence

Letter from Humphrey Wood Esq., presenting the portrait of John May Esq., to the Parish Council as representatives of the Parish of Snodland.

Mr Hodgkinson proposed and Mr Deacon seconded.

That this Council on behalf of the Parish of Snodland accept the gift of an oil portrait in massive gift frame of the late John May Esq., of Holborough, now formally presented by letter, by Humphrey Wood, Esq., with cordial appreciation; they beg to thank Mr Wood for the kind trouble he has taken to place this valuable portrait in the possession of the Parish of Snodland; they further resolve to place the picture in suitable custody and have inserted in the minutes of this meeting a record of the presentation together with the following extracts from Mr Wood's letter, viz:

"The painting belonged to the late Mr John Lewis Levy of Rochester and was sold by auction at his house in 1878 when the family left Rochester soon after his death and I purchased it off a dealer who bought it at the sale.

When I purchased it there was an old paper label on the back of the frame with the words on it "Mr May of Holborough" Carried unanimously.

Mr Deacon proposed and Mr Beadle seconded and it was resolved that the Clerk be instructed to write to the Misses Hook for permission to hang the portrait in the Council Room.

Letter from the Home Secretary read re Scale of Fees. The Clerk's answer to this letter was also read.

Letter from W B Prosser, Esq., Clerk to the County Council was read as also was an order of the Council re book containing a record of the distribution of Godden's and May's Charities – which book was now to pass into the hands of the Parish Council.

The draft deed re clerical fees, rights and privileges in the consecrated portion of the new Cemetery was read, assented and approved.

The draft agreement with the Caretaker was read and approved.

Permission was given to the Caretaker to select boards for graves, and wood for lattice work &c. from Mr Wilford.

Mr Deacon proposed and Mr Hodgkinson seconded that a cheque for five guineas be drawn to pay Caretaker's wages. Carried.

Geo Corney Feby 25 1896

Parish Council Meeting Held in the Devonshire Rooms Tuesday February 25th 1896 At 7pm

Mr Geo Corney presided and there were also present Messrs., Deacon, Archer, Brazier, Fowle, Beadle, Hodgkinson, Kemsley and Hawks.

Report of Brook Committee

Mr Deacon gave a report of the Brook Committee.

He proposed that a new trunk be purchased and placed under the road where the cattle pass over. This was seconded by Mr Brazier and carried.

Mr Deacon also proposed and Mr Brazier seconded and it was resolved that Mr W Hawks be asked to make the trunk.

Allotments

Mr Beadle proposed that the rent of Brook allotments in future be 2d, 3d and 4d. This was seconded by Mr Fowle and carried.

Mr Deacon proposed and Mr Brazier seconded that whole of arrears be collected.

Mr Kemsley proposed amendment that the rent for last year be charged as now fixed. This was seconded by Mr Fowle.

For Mr Kemsley, Archer, Fowle: against Messrs. Brazier, Deacon. Beadle, Neutral. Declared carried.

Correspondence

- 1. Letter from Graham & Sons re new lamp column. Mr Kemsley proposed and Mr Deacon seconded that Mr H Draycon be instructed to put it up. Carried.
- 2. Letter from H Wood Esq., re John May's portrait.
- 3. Letter from the Misses Hook giving permission to the Council to hang the portrait in the Council room. Mr Deacon proposed it to be hung on the wall at the back of the Chairman Mr Brazier seconded and it was carried.
- 4. Letter from Mr Bensted, stating that he hoped to get the whole of the Cemetery work completed in a few days. The Clerk was instructed to write to Mr Langridge about the range in the cottage which was broken.
- 5. Letter from Home Secretary re fee item 3 still insisting that the words "or child under a month old" be inserted. Mr Fowle proposed that the suggestion of the Home Secretary be accepted. This was seconded by Mr Hodgkinson and carried.
- 6. Letter from Mr Lilibourne re fencing.

- 7. Letter from Mr Knight to Rector re Deed. Mr Beadle proposed and Mr Deacon seconded and it was resolved that the surrender of lease from Mr Dalison to Mr Roberts be obtained from the Treasurer.
- 8. Letter from Mr Knight re boundary marks to consecration portion. It was decided to place three stones as marks to define the boundary of the consecrated portion of the Cemetery.

Petition to the Bishop

The petition to the Bishop asking him to consecrate a portion of the Cemetery was read and signed by the Chairman and two members of the Council: Messrs. Corney, Deacon and Hodgkinson.

Fire Extinguishing Appliances, etc

Mr Deacon proposed that application be made to the District Council for permission to place four hydrants in the Parish for fire extinguishing purposes. This was seconded by Mr Brazier and carried.

Mr Deacon proposed that the Clerk be instructed to order the fire extinguishing appliances from the Mid Kent Water Coy. This was seconded by Mr Brazier and carried.

Mr Deacon proposed that the Clerk be instructed to ask Col. Holland for permission to plan a small shed near the Water Coy's office, and Mr Roberts for permission to place one near the Institute. Seconded by Mr Brazier.

Mr Kemsley moved an amendment that one shed be erected in or near the most central place in the Parish. This was seconded by Mr Hodgkinson.

Messrs. Archer, Hodgkinson, Kemlsey, Hawks and Fowle voted for the amendment and Messrs. Deacon Burke and Brazier against it. Mr Beadle remained neutral. The amendment was accordingly declared carried.

Committee to Arrange for Consecration

Mr Hodgkinson proposed that a small Committee be appointed to approach Mr Jackson with a view of arranging the details of the consecration, and that the Committee consist of Messrs. Hodgkinson, Burke, Beadle, Brazier and Corney. This was seconded by Mr Burke and carried.

Printing Rules &c

It was decided to invite tenders for the printing of the Rules, Regulations, and Scale of Fees: 500 copies, and also for 200 copies of Notice of Interment, from Messrs Gay & Sprowson.

Mr Deacon's Notice of Motion re Jubilee Fund

Mr Deacon in accordance with previous Notice of Motion suggested that the Jubilee balance be expended in purchasing seating for the Cemetery.

He proposed that this Council ask the sanction of the Jubilee Committee to purchase seats for use in the Cemetery with the balance left from the Jubilee Fund. Mr Hodgkinson seconded and it was carried.

Mr Corney in accordance with previous notice of motion proposed that this Council recommend the Parish meeting to take the necessary steps to obtain the annexation of Lower Birling with the Parish of Snodland seconded by Mr Burke.

Messrs. Archer, Hodgkinson, Burke, Brazier and Beadle voted for the resolution and Messrs. Deacon, Fowle, Kemsley and Hawks against it and accordingly it was declared carried.

Mr Norman's Account

Mr Hodgkinson proposed and Mr Brazier seconded that a cheque for £13 be drawn in settlement of this a/c: being balance of a/c for laying waterpipe to the Cemetery. Carried.

Lists of Voters

The Clerk was instructed to obtain two lists of voters.

Geo Corney Mar 3rd 1896

Parish Council Meeting Held in the Devonshire Rooms Tuesday March 3rd 1896 At 7pm

Mr Geo Corney presided and there were also present Messrs., Deacon, Hollands, Archer, Hodgkinson, Beadle, Brazier, and Hawks.

Minutes

The Minutes of the last meeting were read and confirmed.

Reports of Committees

Fire Extinguishing Committee

Mr Brazier gave a report in reference to the position of the shed in which to store the appliances.

Five places were mentioned. 1. Bull Hotel, 2. Last end of Mr Tomlin's house, 3. Congregational Church, 4. Water works, 5. The Institute. It was decided to let the matter stand over till the appliances were purchased in order to see what room what be required.

Brook Report

Mr Deacon stated that Messrs. Gad & Sons had made an offer of £3 for 3 willow trees on the Brook allotments.

He proposed that his offer be accepted. This was seconded by Mr Brazier and carried.

Mr Deacon also suggested that the Brook allotments be planted with willow trees and stated that if this were done each tree in about 18 years would be worth £1. He gave notice of motion to bring this matter on at the next meeting.

Cemetery Report

Mr Hodgkinson stated that the Committee had decided to give public notice of the opening of the Cemetery and had issued bills to this effect.

After the consecration of a portion of the Cemetery by the Bishop, the Committee recommended a public opening of the Cemetery and suggested that Messrs. Jackson, Faraday and Archer. Drs Palmer, Freeland, Gash and Smith, the Church warders and overseers and Messrs. W Dedrick Secretary of the New Church, J Mason member of burial board and Mr Robinson Clerk to the burial board be invited to attend. Mr Hodgkinson proposed that this be carried out: Mr Hawks seconded and carried.

Deed re Fees etc

The deed: renouncing fees and ancient rights by the Rector, was read and sealed and signed by the Chairman and Messrs Hodgkinson and Deacon.

The Rev. G H Jackson also attended and signed. The Chairman in a few gracious words thanked the Rector on behalf of the Council for his kindness in making the concessions contained in the Deed.

Correspondence

- 1. Letter from Home Secretary acknowledging receipt of letter.
- 2. Letter from Mr Bensted re accounts and grave spaces.
- 3. Form of notice from DC re hydrants. The Clerk was instructed to hand it over to the Water Company.
- 4. Mr Norman's account: £1-10-0 watering fees in Cemetery. Mr Deacon proposed and Mr Holland seconded that the a/c be paid. Carried.

Roller

Mr Deacon proposed and Mr Hodgkinson seconded that the roller, price 49/6 be ordered from Mr Moore. Carried.

Mats

The Clerk was instructed to inform him (Mr Moore) that the mats must be supplied by Friday morning.

Seats and Desks

The seats and desks in Chapel were referred to the Cemetery Committee.

Matting

Mr Beadle proposed and Mr Hodgkinson seconded that matting be ordered for the Chapel 1½ yards wide @ 2/4 per yard. Carried.

Rollers on Bier

It was decided that the Clerk instruct Mr Langridge to place 3 rollers on the bier.

Gas Pipes for Stump

Mr Hollands proposed and Mr Archer seconded that 12 pieces of gas pipe 18ft long be ordered of Messr CT Hook & Co for marking out grave spaces. Carried.

Hook and Lock to Gate

The Clerk was instructed to call the attention of Mr Langridge to this fact, that there was no hook and no lock to the gate. There is also no wicket gate which matter was referred to the Cemetery Committee.

Grass Seed

The Clerk was instructed to pay for 8lbs of grass seed which had been purchased by the Caretaker.

Fences

The Cemetery fence was referred to Committee.

Agreements

All the Councillors were present and signed the Declaration of Acceptance of Office.

Chairman

Mr Roberts proposed and Mr Burke seconded that Mr Geo. Corney be re-elected Chairman for the ensuing year. Carried unanimously.

The Clerk then read the Memorandum from the Great Government Board respecting the holding of the Annual Meeting and the business to be transacted at such meeting.

<u>Minutes</u>

The Minutes of the last meeting were read and confirmed.

Overseers

Mr Burke proposed and Mr Beadle seconded that two Overseers be appointed from inside and two from outside the Council. Carried.

Mr Deacon proposed and Mr Hollands seconded that the Overseers be elected by ballot. Carried.

Messrs E Brazier and W L H Roberts were chosen from inside the Council.

Mr Deacon proposed Mr Brazier as Overseer and Mr Hollands seconded. Carried.

Mr Beadle proposed Mr W L H Roberts as Overseer and Mr Deacon seconded. Carried.

Messrs J R Holman and J Kemsley were chosen from outside the Council.

Mr Deacon proposed Mr Holman as Overseer and Mr Hawks seconded. Carried.

Mr Burke proposed Mr Kemsley as Overseer and Mr Mason seconded. Carried.

Mr Deacon proposed and Mr Hollands seconded and it was carried that the election of Vice Chairman be by ballot.

On Mr Roberts being selected, Mr Burke, proposed and Mr Hawks seconded that he be re-elected Vice Chairman. Carried unanimously.

Committee

Mr Beadle proposed and Mr Deacon seconded and it was resolved that three Committees be formed. Brook Committee, Cemetery Committee and Lighting and Finance Committee as suggested by the Chairman.

Mr Roberts proposed and Mr Godfrey seconded and it was resolved and each committee consist of five Councillors.

Brook Committee

Mr Roberts proposed that Messrs Deacon, Brazier, Fowle, Mason and Godfrey form the Brook Committee this was seconded by Mr Hollands and carried.

<u>Cemetery Committee</u>

Mr Godfrey proposed that Messrs Fletcher, Burke, Fowle, Beadle and Hawks form the Cemetery Committee. This was seconded by Mr Deacon and carried.

<u>Lighting and Finance Committee</u>

Mr Deacon proposed that Messrs Hodgkinson, Roberts, Hollands and Brazier form the Lighting and Finance Committee. This was seconded by Mr Fletcher and carried.

Election Expenses

The Clerk submitted the Returning Officer's bill for election expenses which amounted to £16-1-11

Mr Hodgkinson proposed and Mr Roberts seconded that a cheque be drawn for this amount to settle this account. Carried.

Cemetery Committee Report

Mr Hodgkinson read Cemeter Committee report. This Committee met on Saturday April 11th and drew up a specification of the work to be done, viz setting back pillar, unmoving wall and fence, at entrance, building wall 3ft 6in height with iron fence 3ft high on top, along the east side of cemetery, and had asked Messrs Wilford, Langridge and Norman to tender for same.

Mr Roberts proposed that this matter be referred back to the Cemetery Committee because the Council were unable to determine whether it would be better to build the wall in a drop level or according to the rake off the road. No seconder.

Mr Hollands proposed that the wall be built in drop level sections. This was seconded by Mr Haws and carried.

Mr Roberts proposed that the tenders be returned to the builders unopened and ask them to wait further instructions from the Council. This was seconded by Mr Hawks and seconded.

Mr Mason kindly promised to make a plan and specification of the work to be done and submit to the Council.

Brook

Mr Deacon suggested that some old wire rope be purchased and placed along the side of the Brook adjourning Birling Brook, about 910ft to prevent cattle straying from Birling Brook on to the allotments.

Mr Roberts promised to supply the old wire rope.

Mr Deacon proposed and Mr Roberts seconded that this work be done. Carried.

Mr Deacon also suggested that the Clerk be able to obtain the advice of 1 or 2 of the Cemetery Committee in cases of emergency.

This was seconded by Mr Hodgkinson and carried.

Interments in the Churchyard

Mr Corney reported that he had spoken to the Rector re interments in churchyard. The Rector stated that he was willing that all future interments should be made in Cemetery but he was not sure he had the power to refuse if persons insisted on being buried in churchyard.

Mr Fletcher recommended that the Clerk write to the County Council and call their attention to the bad state of the footpath in the Holboro Road.

Mr Burke gave notice of motion. That this Council do summon a Parish meeting for the purpose of considering the question of adopting the Baths and Washhouses Acts (1846).

Mr Fletcher recommended that the Clerk write to S E Ry Co and ask them to provide shelter accommodation on the down platform.

Mr Deacon proposed and Mr Godfrey seconded that 8 6ft seats, No. 15 in Boulton & Paul's list (16/-6 each) be purchased and placed in the Cemetery and paid for out of the "Jubilee Balance". Carried.

Correspondence

1. Statement of accounts from Rochester Bridge Wardens. Taken as read.

2. Letter from Kent County Council stating that the Bridges and Roads Committee had decided not to repair the kerb in the Holboro Road. Mr Beadle proposed and Mr Deacon seconded that the Clerk be instructed to write and urge that attention be given to the state of the kerb in the Holboro

Fire Brigade

Road. Carried.

The following names were submitted as volunteers to the Fire Brigade.

Messrs. Geo. Taylor, Albert Paddick, Thomas Banks, Charles Needew, Thomas Fletcher, Charles Corney, James Woodruff, Harry West, William Reynolds, Arthur Woodruff, William Stephens, Hubert J Penney, Thomas Batchelor and Joseph Woodford.

All were appointed and on the proposition of Mr Deacon seconded by Mr Brazier it was unanimously resolved that Mr H J Beadle be appointed Captain.

Brook

Mr Deacon called attention to boys and others riding horses and worrying cattle on the Brook whereby serious damage had ensued.

Mr Beadle proposed and Mr Deacon seconded that 50 notices of warnings be printed and posted in the Parish. Seconded.

Mr Deacon gave a Notice of Motion re the position of the Notice Board at the Cemetery recently erected by Mr R Langridge of Ham Hill.

Geo Corney Aug 18 1896

Parish Council Meeting Held in the Devonshire Rooms Tuesday August 18th 1896 At 7pm

Mr Geo Corney presided and there were also present Messrs., Hodgkinson, Godfrey, Brazier, Hawks, Fletcher, Fowle, Hollands, Deacon, Beadle, Burke and Mason.

Minutes

The Minutes of the last meeting were read and confirmed.

Brook

Mr Deacon reported that the Bridge on the Brook had been repaired as had also the planks at the commencement of the willow walk.

Mr Deacon stated that Col Holland by mistake or otherwise had enclosed a portion of the Common land and he proposed that the Clerk be instructed to write him calling his attention to same and requesting him to remove the fence to his own ground. Mr Hollands seconded and it was carried unanimously.

Fire Brigade

Mr Hodgkinson read the proposed rules for the management of the Fire Brigade. He also stated that Mr W Stevens had been appointed sub-captain, Mr J Woodford Lieutenant and Messrs H Penny and A Woodruff engineers and Mr Charles Corney Secretary of the Brigade.

Mr Hodgkinson proposed that the rules submitted be sanctioned by the Council. This was seconded by Mr Deacon and carried.

Mr Beadle explained that the Fire appliances provided by the Mid Kent Water Coy., were not perfect and suggested that they be put in working order before paid for. He also stated that sufficient hose had not been provided.

Mr Deacon suggested that the Clerk report the position of the Lighting account at the next Meeting.

Cemetery Committee Report

Mr Burke read the report of the Cemetery Committee.

Its recommendations to the Council were:

- 1. To allow the seals to remain as placed by the Caretaker.
- 2. That the stays be provided for the poplar trees, also a ball of spun yarn.
- 3. To raise the road next the wall as suggested by the Caretaker.
- 4. To order 2 more load of free gravel from Mr W Hawks to complete the work.
- 5. That the attention of Mr Langridge be called to the state of the Caretaker's bedroom over the archway and request him to attend to it at once.
- 6. That protection stones be placed against the wall at the bend at the top of the road
- 7. That the Caretaker continue to dig the graves in the order began.
- 8. That 3 casts of flower pots be purchased for the use of the Caretaker.
- 9. That a blower be provided for the use of the Caretaker.
- 10. That a stop cock be placed outside the house.

Mr Burke proposed the adoption of the Cemetery Committee's report, Mr Hodgkinson seconded and it was carried.

Grass in Cemetery

Mr Deacon proposed and Mr Beadle seconded that Mr Hollands be asked to sell the grass in the Cemetery for the best price he can get. Carried.

Annexation Committee Report

Mr Godfrey read the report of the Annexation Joint Committee. The area of portion of Birling proposed to be annexed to Snodland is 65a 1r. 26p. It recommended the distribution of the Charities to remain as at present, and that the portion of the Brook to be annexed be decided by acreage, which would give Snodland 6a 1r 35p. Mr Godfrey proposed that the report of the Annexation Committee be adopted as read, and that the same be submitted to a Parish Meeting if the Birling Parish Council approve of it.

This was seconded by Mr Hodgkinson and carried unaminously.

Correspondence

- 1. Letter from Mr Porter, Secretary of Snodland Congregational Church re shed for storing fire appliances. Referred to Lighting Committee.
- 2. Letter from Mr Wagon, Clerk to the Burham Parish Council, stating that the Rev. A E Bourne and Messrs. W F Mills and A Neale had been appointed to act on the Bridge Committees. Referred to Bridge Committee.
- 3. Letter from Mr Prosser, Clerk to the County Council, stating that matter which have been considered dealt with by the Bridges Committee cannot be again brought forward till after the lapse of twelve months. Mr Beadle proposed and Mr Hollands seconded and it was resolved that the Clerk be instructed to write again concerning the matter of the kerb in the Holborough Road.
- 4. Letter from the Misses Hook thanking the Council and Committee for the thoroughness with which everything connected with "Welcome home" had been carried out. Mr Godfrey proposed and Mr Burke seconded and it was resolved that the letter be copied into the minutes, and the Clerk was instructed to acknowledge the receipt of the letter stating same. The spirit of friendliness which pervaded the meeting made it a time to be long remembered, and we now have had time to examine the exquisite taste, colouring and workmanship of the splendid illumination and its handsome frame, as well as the happily chosen words of the address, while it is quite a treat to handle the choice and solid binding of the much prized album.

Mr Burke proposed an amendment that the matter be referred to the Cemetery Committee. Mr J Fowle seconded and it was carried. Messrs Deacon & Hollands alone voting against it.

On being put as the substantive motion it was carried unanimously.

U. J. C Letter

Mr Deacon proposed and Mr Fletcher seconded that a letter in the form of a testimonial be sent to J C Mullard expressing general satisfaction of the way in which he had carried out his duties during the seven years he had been stationed at Snodland. Carried. Mr Fowle remained neutral.

Gassons

Mr Deacon stated that the "Gassons" Estate could not be identified. He suggested that steps should be taken to determine the situation and when found, have it marked on the Ordnance map to be purchased. He gave notice of motion re map.

Report of Finance

Mr Hodgkinson presented the Finance Committee Report.

Storage of Fire Appliances

Mr Hodgkinson proposed and Mr Deacon seconded and it was resolved that the Council accept the offer of the Misses Hook to allow the use of the Soup Kitchen for storage of the fire extinguishing apparatus and also for the meetings of the Fire Brigade at an annual charge of one guinea – and that the Clerk be instructed to gratefully state their acceptance by letter to the Misses Hook and to reply to the Congregational Trustees, thanking them for their kind offer to find a place of storage.

Funding of Extra Hose

Mr Beadle proposed and Mr Brazier seconded and it was resolved "That finding the present supply of Fire Hose Pipe is quite insufficient two additional lengths of 100ft shall be purchased and that the Council instruct the Captain of the Fire Brigade to order the printing of 50 copies of the Rules approved by the Council and purchase a supply of 1 ½ dozen copies of the Manual Guide for the use of Fire Brigade Members."

Clerk's Salary

Mr Mason proposed and Mr Fowle seconded that considering the additional duties imposed as Clerk to the Council the salary, including payment for all services as Assistant Overseer and Clerk to the Council now standing at £60 per annum should at the beginning of the next financial year be raised. Carried.

Mr Beadle proposed that Minute Books be supplied to each Committee. This was seconded by Mr Hodgkinson and carried.

Willow Trees

Mr Deacon suggested that the Caretaker be instructed to break off twigs of the willows trees on the Brook.

Cemetery Committee Report

Mr Beadle read the Cemetery Committee Report.

Mr Beadle proposed that the stop cock to the Caretakers house be placed outside the gate. The work to be done at once by the Water Coy. This was seconded by Mr Mason and carried.

Mr Fletcher proposed and Mr Deacon seconded that the Caretaker be allowed to purchase bulbs up to the value of one guinea for planting in the Cemetery. Carried.

Mr Beadle proposed and Mr Fowle seconded and it was resolved that the Caretaker's room be attended to at once and an iron bar be replaced on the sill of the lower rooms.

Mr Fowle proposed and Mr Fletcher seconded that the Caretaker have power to purchase manure for the Cemetery not exceeding 8 loads. Carried.

Mr Fowle proposed and Mr Beadle seconded and it was resolved that the Notice Board remain as it is at present.

Mr Fowle proposed that the seats at the Cemetery be placed in the Chapel during the winter months. This was seconded by Mr Deacon. Carried.

Mr Beadle proposed that the sharpening and repair of tools be undertaken by Mr Hinds. This was seconded by Mr Fowle and carried.

Mr Hawks proposed and Mr Beadle seconded that the bier be reduced in height by 2". Carried.

Mr Beadle proposed and Mr Deacon seconded that offer of Mr Roberts to supply about ½ dozen sacks of cement which had set, to be used as spur stones, be accepted, and the Clerk be instructed to convey to Mr Roberts the best thanks of the Council for the gift. The Clerk was also instructed to arrange for the transference of the stones from the "Works" to the Cemetery. Carried.

Mr Beadle proposed and Mr Fletcher seconded that a greenhouse and tool shed be erected on the piece of ground next the fence on the South side of the Cemetery – the size of green house to be 16 x 10 and the tool shed 8 x 10. Carried.

Mr Beadle proposed and Mr Hollands seconded that the matter be referred back to the Committee in order to obtain plans and specification. Carried.

Mr Hollands reported that he had sold the grass at the Cemetery to Mr W Cunningham for 5/-.

Correspondence.

- 1. Letter from Col. Holland re Brookland.
 - Mr Deacon proposed that the Chairman and Clerk be instructed to wait on Col. Holland and request to see the Title Deeds, and satisfy themselves that the boundary is in accordance with the plan, and if so to let the matter rest. This was seconded by Mr Hollands and carried unanimously.
- 2. Letter from Sergeant Mullard.
- 3. Letter from Birling Parish Council re annexation scheme.
- 4. Letter from Inland Revenue Office stating the Claim would be allowed.

Mr Deacon read a letter from the Charity Commissioners in reference to £2-2-0 mentioned in John May's will and also to the distribution of Great Coats to persons in receipt of Parish Relief. Mr Deacon proposed and Mr Beadle seconded that the letter be copied in the Minutes. Carried.

Copy of letter from Charities Commissioners to the Rev. G H Jackson dated Sept. 21st 96.

Rev. Sir

In reply to your letter of the 3rd instant I am to state as follows –

- 1. The annual sum of £2-2-0 granted by this donor was to be applied towards the expenses of the annual meeting of the acting magistrates of the division by whom the donor desired that the accounts of the Charity should be audited. Regard being had to the fact that the accounts are not audited by the Magistrates and that the payment in question has never been made, it is not advisable that any steps should be taken with the view to enforcing payment but it is open to the Trustees to ask the present owner of the land charged whether he would be willing to make the payment of £2-2-0 in the future as an augmentation of the rent charge of £20 a year for Charitable purposes.
- 2. It is a principle of the law of charitable trusts that funds subject to those trusts should not be applied for the benefit of those who are in receipt of parochial relief, and who are then entitled as of right to an adequate maintenance. Following the practice of the Chancery Division of the Supreme Court, the Commissioners would not entertain an application for authority to extend the benefits of this Charity to persons receiving poor law relief, I may add that in the present case the donor expressly directed that such people should not be beneficiaries of this Charity.

Minutes

The Minutes of the last meeting were read and confirmed.

Report of the Cemetery Committee

Mr Burke read the report of the Cemetery Committee.

It recommended that the whole of the greenhouse and tool shed should be covered with glass, a door at each end and a door in the partition, that there be 3ft of brickwork above the ground, that the Clerk be instructed to write to Messenger & Co., and ask them to recommend suitable heating apparatus and that the Clerk give a letter of introduction for the Caretaker to purchase bulbs, trees and shrubs upto the value of £2-11-0.

The plan and specification for green house were submitted and a letter from Messenger & Co recommending suitable heating apparatus was read.

Mr Burke proposed that the Cemetery Committee's report be adopted as read and that tenders for the erection of the green house be invited. This was seconded by Mr Fowle and carried.

Mr Burke proposed that Messrs Wilford, Norman, Langridge, Draycon and W Hawks be invited to tender and that the tender be returned not later than Thursday Nov. 5 6pm. This was seconded by Mr Hodgkinson and carried.

The work to be completed in a month from the date of the acceptance of tender

Minutes

The Minutes of the last meeting were read and confirmed.

Report of the Brook Committee

Mr Deacon read the report of the Brook Committee.

Its recommendations to the Council were:

- 1. That the steps and rails in the willow walk be repaired.
- 2. That all the dead tree trunks be removed from the willow walk.
- 3. That the ditches beside the willow walk and the ditch round the allotments be cleaned out and that James Hogben be employed to do the work.

Mr Deacon proposed and Mr Fletcher seconded and it was resolved that poor people be allowed to remove the dead tree trunks to use as firewood.

Report of the Cemetery Committee

Mr Burke proposed that the Clerk be instructed to write to the Undertakers and ask them to give the exact size of the coffin when applying for an order for a funeral. This was seconded by Mr Hodgkinson and carried.

Mr Burke proposed, and Mr Godfrey seconded, and it was resolved that 1 chaldron of coke and ½ ton of fine coal be ordered for Mr Tomlin for use at the Cemetery, and that a wire sieve be purchased for the Caretaker's use, at Mr Moore's and that a few alterations be allowed in building greenhouse.

Report of the Fire Brigade Committee

Mr Beadle proposed that the Messrs. Hook's offer of the cottage behind the Water Works Office in the High Street, for a store for the fire extinguishing apparatus, at a rental of £5 per annum on a seven years lease with option of renewal be accepted with best thanks. This was seconded by Mr Deacon and carried.

Correspondence

Two letters from the South Eastern Railway Company respecting the stopping of the down 10.10 am train were read.

Mr Beadle proposed that the Clerk be instructed to write to the Manager thanking him for his promise to consider the question at the commencement of the New Year and urging the very great importance to the public of a decision in favour of the stopping of the down 10.10 train at Snodland Station. This was seconded by Mr Godfey and carried.

Letter from Mr Wd Johnson was read asking to be allowed to make a road across the Brook to the Saltings for the use of which he was prepared to pay a nominal rent. Mr Deacon proposed and Mr Brazier seconded and it was resolved that the Clerk be instructed to inform Mr Wd Johnson that the Council were unable to give the required permission to make a roadway across the Brook.

Finance Committee Report Receipt on Overseers

Mr Hodgkinson proposed that a precept for £120 be issued on the Overseers for meeting the expenses connected with the Cemetery.

This was seconded by Mr Burke and carried.
