Fire Brigade

Mr. Norman read the report of the meeting held on October 13th to which the Chief Officer and three Firemen had been invited.

The Chief Officer explained that the shift system on the Factories prevented the men from attending the drills regularly, never the less every care was taken and in one single case had the Parish been let down in case of Fire Calls the men had responded immediately.

The usual procedure for long service Medals was for a Fireman to make a written application for this which was forwarded by the Chief Officer to Headquarters with records of Fireman's services.
