The top part of this road was also in a bad state, Mr. Monk proposed "That Malling Rural District Council be asked to put this in reasonable repair. Seconded by Mr. Saul.

Baths

Mr. Gower reported the number of Bathers for the last five weeks to be 542, and the fees amounted to £4.15.9d, as compared with 647 and £5.14.11d. for the corresponding period last year.

The tenders of Mr. Draycon for 12' close boarded fence for £4.17.0d, and Crowhurst for a stile fence £2.12.6d. was accepted.

Fire Brigade

Mr. Hammond presented the report of the Fire Brigade Committee Meeting held on January 17th to meet Mr. Bundy and Chief Officer Hinds.

Mr. Bundy explained in detail the new arrangements under which the Malling Rural District Council proposed to work the Fire Brigade of their area under the new Act. He pointed out that the Parish of Snodland, being within a running distance of about 15 minutes from Malling, and being geographically situated at the extreme end of their area was not considered a suitable one to station a Fire Brigade.

After having talked the matter over with representatives of Malling Rural District Council he agreed to recommend the Home Office to allow an engine to be stationed here. In order to do this, the Council must agree for the Malling Fire Engine, after being reconditioned, and brought up to the requirements and strength required by the authorities to be stationed at Snodland. Malling would have the new Engine. The reason for this is, Malling being more central would have to serve 12 ½ Parishes, and necessarily requires real up to date equipment. Snodland would be sufficiently covered. The question of schedule of apparatus and equipment and prices was then considered. It was pointed out Snodland Engine to all intents was worthless after this year. Hose, it was very questionable whether any of this, if put to the test would stand up to the pressure. Uniforms were very much worn and value reduced. After carefully considering the whole position with Mr. Bundy and Chief Officer Hinds, it was agreed to recommend the Council to accept the sum of £75, for the schedule as presented, against the sum of £96.12.0d. as specified. Mr. Bundy assured Snodland they were acting wisely on agreeing to this arrangement. He said he would see we got a good Engine and equipment and later on things would "Not be worse", Mr. Hammond moved the adoption of the report. Seconded by Mr. Saul and carried.

Fire Station

The question of rental of Fire Station was discussed, but left over until hearing from Ministry of Health.

Lighting

Mr. Wray asked for lamp in Bramley Road to be lit. This was referred to Lighting Committee.

Recreation Ground

Mr. Stotesbury reported the trenches not yet filled in. This was left for him to deal with.

Meeting of the Council Held in the Devonshire Rooms on Tuesday February 28th 1939 At 7.30pm.

Present Messrs B.H. Norman (Chairman), J.J. Hammond (Vice-Chairman), Bishop, Freeman, Gower, Harrington, Hood, Monk, Saul, Stotesbury, Tobin, Wray and F. Simmons, Clerk.

An apology was received from Mr. Greenacre for non-attendance.

Minutes.

The Minutes of the last Meeting were read, confirmed and signed.

Baths.

Mr. Gower reported the number of Bathers for the last five weeks to be 632, and the fees amounted to £5.5.11d, as compared with 680 and £5.19.6d for the corresponding period last year.

Also, that an emergency Committee Meeting had been held on 21st February. Mr. Gower apologized for the short notice given, and explained the urgent position that had arisen at the Baths, owing to the serious illness of the Caretaker. After two serious breakdowns he had been removed to Hospital at Malling. Meantime Abery was assisting with fires etc. Mr. Gower had interviewed Mrs Judges who stated it was quite impossible for her to continue to carry on here. Also, the son stated he would help his Mother to vacate the premises at the earliest possible moment. The Committee felt that the vacancy should be advertised this week to save time without waiting for full Council meeting. They hoped the Members would approve of this course. Applications to be in time to be placed before the Council on the 28th inst. Temporary assistance to be continued as at present arranged pending further

developments. The question of Caretaker's wages to be considered at a later meeting.

Since the meeting, he regretted to report the death of Caretaker Alfred Judges. He proposed that a letter of condolence be sent to the family expressing the Council's extreme regret at the loss of their esteemed and respected Baths Caretaker, and extending their sympathy to them in their great loss.

Brook

Mr. Hammond reported that the survey was making a good job of the roadway leading to the Brook.

Cemetery

In the absence of Mr. Greenacre this report was given by Mr. Gower as follows. The meeting was called to consider the position regarding the purchase of extra land for Cemetery extension.

Mr. Monk explained the meeting that he and the Clerk, had had that day with the District Valuer who expressed surprise that the Parish Council had provisionally accepted the price of £200, per acre without consulting him. He still pointed out his value was £100 per acre. He had not replied to the Parish Council's letter which pointed out the position.

The Committee were not satisfied we had acted wrongly. Mr. Hammond proposed, Mr. Filmer seconded that the District Valuer be asked to reply to the letter. Also pointed out to him the urgency of the situation. Price originally £400, present offer £200. The Council felt they should make a deal, even at this price, subject to the District Valuer agreeing. Considering we were being surrounded by pits, isolating our Cemetery, which is filling up. Unless the deal is fixed it would necessitate other compulsory powers as to negotiate for land, perhaps a mile or two away. This would be an enormous expense to Rate-Payers, and hardship to inhabitants. Loan suggestion would be, say £350 for land, fence and layout.

It was recommended to purchase for use at Cemetery, 6, Grave Boards, 9' x 9" x 1" & 2, 8' x 9" x 1", also a 1 ½ Gall Water Cans . Mr. Monk proposed and Mr. Hammond seconded that the report be adopted. Carried.

It was decided to obtain prices from Ashby and Cook for clearing the surplus chalk and were from Cemetery and carting to rubbish dump on Brook, also for supplying 4 loads of Manure. Chairman and Clerk to arrange on receipt of quotation.

Conveyances

Mr. Gower proposed, that the conveyance of Grave Space No. 1439, section B Consecrated portion to Emma Fowle, also Grave Space No. 1440, Section B Consecrated portion to Ellen Rose Gooding, be signed by the Council. Seconded by Mr. Hammond and carried.

Inscriptions

Mr. Gower proposed, that additional inscription to Grave No. 230, also additional inscription to Grave No. 364 be approved by the Council. Seconded by Mr. Hammond and carried.

Plan

Mr. Gower proposed that the plan of Vase submitted for Grave No. 1419 be approved by the Council. Seconded by Mr. Hammond.

It was again brought to the Council's notice that Mr. Robert's fees were not yet paid. After consideration Messrs Freeman & Monk kindly agreed to interview him.

Lighting

It was reported that a Lamp Column and Lantern had been knocked down in the Church Fields. Price £9.14.6d. The Clerk had the matter in hand.

Mr. Wray again urged the Lamp in Bramley Road should be alight, and called attention that a Committee Meeting had not yet taken place. The Chairman of the Lighting Committee being absent, the Clerk said he would consult with him on the matter.
