Mr. Wray gave a detailed account of a Committee Meeting and submitted a draft of new rules for the regulation of the management of the Brook, but owing to the small amount of Councillors being present it was arranged to postpone decision until next month meeting, meantime the Clerk to supply each member with a copy of the old rules, also the suggested new ones.

He also reported that Blackman had made a "Dug-Out" on the Brook land without consent of Council. The Clerk was instructed to write Blackman and ask him to put the whole thing back in proper order, or to make the dug out quite safe to prevent any Cattle getting injured.

It was agreed to ask Crowhurst for estimate to put boundary fence in order.

Cemetery

Mr. Greenacre reported that 4 loads of Manure were requires and suggested Ashby & Cook be asked to quote. At the same time to clear the whole of the surplus Chalk and rubbish to entrance gate of Brook or dump as required.

He also reported that the mowing machine had been sent to Haynes Bros for overhaul, and that the usual quantity of seeds ordered for Caretaker.

After perusal of letter from Ministry of Health it was arranged for a letter to go to Kent County Council, pointing out that it was very essential that a farther strip of land for extension purposes must be obtained with as little delay as possible, and in view of the position between the Associated Portland Cement Mfrs' and District Valuer to advise us as to our next procedure.

Mr. Gower read the report of the Lighting Committee Meeting held on January 16th, which stated the meeting was called to consider the letter received from the Mid Kent Gaslight & Coke Co. relating to payment of charges during the time lighting restrictions are in operation. The matter was carefully considered at some length, but no decision could be arrived at, and the Meeting was adjourned until Friday, January 19th.

At the adjourned Meeting, a report was received of enquires that had been made, and it was decided to recommend the Council to make an offer to the Mid Kent Gaslight & Coke Co., to pay their charges in-full.(say £56.5.0d.) for the first year from the date of restrictions, afterwards at the rate of 3/- per lamp per annum (or proportion of year) for the remainder of period which restrictions are in force. Mr. Monk proposed that the report be adopted. Seconded by Mr. Stotesbury and carried

Mr. Hammond proposed that the report be adopted. Seconded by Mr. Saul. Mr Stotesbury proposed that Mr. Freeman be given power to act in the matter of fence and gate at Malling Road entrance. Seconded by Mr. Hood and carried.

Baths

dykes each side of Willow Walk as far as Railway should be cleaned. Fence at double stile on Willow Walk to be repaired. Willow Walk path, between stile and white bridge in very bad condition, bordering on dangerous.

Boundary fence Mill Stream side needs repairing. Fences at Salt Dyke should be cleared away and 50 yards of new to replace it. This will prevent cattle straying on to private property. He was also one of the Parish representatives on the Malling Rural District Council, and member of the Kent County Council, and held several other important offices. His expert advice on local affairs was often sought and readily given.
