Meeting of the Council Held in the Devonshire Rooms on Tuesday 26th January 1943 At 7.30pm.

Present, Messrs Gower, Austen, Robinson, Hood, Sabine, Saul, Beech, Bishop, Filmer, Stotesbury, Rev. J.S. Granger, Hughes, Tobin, Finch and the Clerk.

Minutes

The Minutes of the last Meeting were read, confirmed and signed.

A deputation consisting of Chief Officer Hinds & Fireman Smith waited to place before the Council their views on the new arrangement of the N.F.S.

On the proposal of Mr. Saul, seconded by Mr. Stotesbury. The standing orders of the Council were suspended and the business of the deputation taken at this point.

Mr. Smith (Fireman), stated that the Snodland section of the N.F.S. felt they were being treated somewhat unfairly, and that the Parish of Snodland was not receiving the necessary efficient fire service that was due to it, considering the many important business premises in the Parish.

In the case of an emergency much valuable time would be lost by the new arrangements.

The telephone had been removed from his residence. Chief Officer Hinds supported Mr. Smiths remarks and said he had already protested to the Chiefs about this change.

He felt that after serving the Parish of Snodland very efficiently for many years, having now to refer to the neighbouring Parish of Halling for instruction was something of a slight on this Parish.

The Chairman pointed out that the Parish Council had no controlling powers over the Fire Service arrangements now. They were governed entirely by the N.F.S. But this Council naturally felt that the Parish of Snodland must be safeguarded.

The Council, after discussion promised to support the protest made by the Firemen and take the matter up strongly with the Malling R.D. Council.

The Rector suggested when a reply was received to the protest a special Meeting of the Parish Council be convened and Chief Officer Hinds and Fireman Smith be invited to attend.

The Members agreed.

Baths

Mr. Robinson reported the number of Bathers for the last five weeks to be 480 and the fees amounted to £6-10-2d, as compared with 666 and £6-8-10d for the corresponding period last year.

Mr. Robinson said the reason for the drop in the Bathers was through trouble with the water, and that the Baths had to be closed for some time. This matter has now been put right by the Water Co.

Brook

Mr. Beech said nothing to report.

Allotments

Mr. Hood reported that he had seen Mr. Lucas regarding the Rubbish Dump on his Allotment, and a reduction of rent for 2 rods be made.

Cemetery

Mr. Stotesbury reported that Mr. Evenden had been ill, this was the reason that help had been obtained, to help with the Grave digging. Evenden was now back at work. He also said that no Glass had been broken from the Bomb blast.
