#### VELES [Tithe 439]









Detailed records of ownership and occupancy for a house on this site begin only in 1769, but one would have been built here much earlier. One cannot help but wonder whether the curious gift of 'an ancient sun dial (date 1417) by Mr. Bridge' at the opening of the New Jerusalem church actually came from the rebuilding of the Hook family house. Bridge had built the church and may also have rebuilt the house. One man who may have once lived there was Walter/Watkyn Andrew (died 1463), who certainly had 'tenements' in Burgate Street (the old name for the High Street). In his will he decreed that his wife Alice could 'live in my tenements in Burgate Street' for the rest of her life; then they were to be sold and the money 'coming to my executors was to be given to an honest priest to sing for my (and other) souls in the church of Snodland.' The Andrew family was prosperous and had many houses and much land in Snodland, Birling and Halling. Walter's sons were Robert (died 1488) and Walter (died 1512).

A more positive identification of ownership comes with the Coveney family, who were well established in the area. A William Coveney married Joan Leeds (of Court Lodge by the church) on 10 May 1572, but he seems to have died within a few years, since Joan Coveney married a John Burchett (parish unknown) at All Saints. Snodland, on 9 July 1592. A deed of 14 June 1613 suggests the sale of the house by an executor acting for Edward Coveney of Addington, deceased, perhaps William's son. <sup>1</sup> The property is described as a

Messuage, kitchen, malthouse, barn. stable, three gardens, orchard and 12 pieces of land, together with 3 acres adjoining the tenement. Clement Whitfield, late Edward Leedes E & S;

Highway and lands of Clement Whitfield and Alice Forward, widow, and Henry Cheeseman W; Highway N; in Burgate Street.

The description fits the site well, with the highway on the West being Brook Street and that on the North being the High Street.

Nothing more can yet be ascertained until the Churchwarden's accounts begin in 1769. At that time 'Mr Austin' (either Richard or Robert) was paying the rent, but on 4 May 1779 'Mr Johnson' (sometimes called Berryman and sometimes Benjamin) paid £8 'for late Austin's rent'. Land Tax records also begin in 1780, sometimes naming the occupants as well as the owners: John Alldridge (1780-3), Armigill Hadlow (1784-5), William Butler (1790), Rolfe Hutson (1791-2). However, it seems that at least in Berryman Johnson's time the property was used to house the poor — perhaps an overflow from the Poor Houses opposite. The names of John Alldridge, William Butler, and Rolfe Hutson all appear regularly in the Overseers Accounts as poor men. And in 1785 Armigill Hadlow's family were deported to Maidstone, although other Armigill Hadlows continued to prosper in Snodland.

In 1793 ownership passed to John May and the house began its association with the managers of the paper mill, beginning with Isaac Wenman the younger (1796-1806). Others who lived there were Thomas Cleaves (1807-10) - not a papermaker (but he was a beneficiary in John May's will), William Spong (1811-23), William Joynson (1824-33), John Clark (1834-41) and William Wildes (1847-1854). Ownership of the property in this period is shown as John May (1793), John Spong (1795-1801), John Spong junior (1802-7), Thomas Cleaves (1808-10), William Spong (1812-22), John Dudlow (a local lawyer and landowner) (1823-39); Henry Phelps (Rector of Snodland) (1840-65).[See A Ashbee, *The Papermakers of Snodland, c.1740-1854* for full details — also online at Kent Archaeological Society/members publications)

Maude Midsummer Hook died on 29 September 1930 at her house at Hove. She is buried with the rest of the family at Maidstone Cemetery. She was the last of them and all the properties were sold at auction at the Bull Hotel, Rochester, on 3 December 1931. Veles was bought by the Paper Mill and was demolished to be replaced by workers' houses in May Street, Brook Street and the High Street. Eight houses called Veles Gardens were built in the High Street, numbered 98-112 and were demolished around 1980 to make way for the by-pass.



## **IVYMEATH**

The house was built around 1878-9 by Colonel Trevenan James Holland (b. Bombay, 31 May 1854; died 12 Feb 1910 at Tunbridge Wells) when he took over the management of the Paper Mill following the death of Charles Townsend Hook in February 1877. A note in our copy of the 1906 auction says: "'Ivymeath'. The name of the house is believed to have been made up from the initials of the three sisters of Charles Townsend Hook: M. E. A. standing for Maude, Edith, Agnes, T. H. for Townsend Hook and the Ivy for we cling together.

Holland's family were living there by 3 April 1881 when the census was taken, but moved to Tunbridge Wells in July 1889.

Holland.—Colonel Trevenen James Holland, C.B. D.L., J.P., Mount Ephraim House, Tunbridge Wells; son of Colonel James Holland. Entered the Army in 1852; served as A.D.C. to Lord F. Fitz-Clarence, Commander-in-Chief of the Army in Bombay; also as Government Interpreter in Schindhee, Persian, Arabic, and other Asiatic tongues; was with the 10th Hussars in the Crimea; became Deputy-Assistant-Quartermaster-General at Bombay in 1854; served as Assistant-Quartermaster-General through the Persian Campaign, Indian Mutiny, China Campaign, and Abyssinian Expedition of 1867, being present at the capture of Magdala; was made C.B. in 1868, and has received many medals and orders; is a Deputy Lieutenant and Justice of the Peace for Kent, and a Justice of the Peace for Cornwall and Sussex; Alderman of Kent County Council; contested Colchester as a Conservative in the Parliamentary Election of 1900. Married,

in 1868, the daughter of the late Peter Nicholson, of Strath, Isle of Skye, and has issue one son, Charles Trevenen, Lieutenant, Royal Field Artillery, and three daughters.





Walter Eveling (1840-1923) in his alderman's robes of the City of Rochester

[SHS Newsletter: Dec 1998 and thanks to Dr David W Eveling]: 'Among visitors [to Snodland] were Mr and Mrs D. Eveling from Lincolnshire. Mr Eveling's great grandfather Walter Eveling was a long-time owner and resident of 'Ivymeath', we think from 1906 when the house was sold. He was also an alderman of Rochester and member of the family firm Eveling


and Co., noted as 'linen and woollendrapers, 158, High Street', Rochester in the 1838 directory. Mr. Eveling has

a fine portrait of Walter in his alderman's robes and was told that a similar picture once hung in one of the Medway civic halls, at Rochester or Chatham. His aunt, now aged 93, visited 'Ivymeath' as a child and remembers the military exercises of the Volunteers which took place in the Rectory Drive during the First World War (and which are recorded in the Parish Magazine; the Rector was commandant of the Volunteers at the time.)





## THE RECTORY



The earliest Rectors were unmarried and either lived in the church or stayed in the homes of parishioners. It was only from the mid-16<sup>th</sup> century that they could set up a family home. The first Rectory in Snodland was situated roughly where the boundary between Ivymeath and the cricket field is today, as revealed in the sketch by Rev Phelps. [Thomas Washer (Rector 1713-1748) described it in 1724: "The Parsonage House is part old and part new. The old containing a large hal1, and a smal1 parlour, over which are two chambers, and the building is of a single brick. The new part is of the same, two bricks and a half thick, and contains a kitchen, a dary (sic), and a cellar over which are two bedchambers, and over them two garrets." [KHLC] 01-07-1725: DRb/Am 2, f.131r is a petition by Rev Washer "that the barn

belonging to the ... Parsonage House of Snodland commonly called the fother Barn is at this time very ruinous and in danger of falling down". Petition to demolish it was granted: "exclusive of the said fother Barn there is sufficient Barn Room for to hold more than all the Corn, Hay, or that grows upon the Gleab or can be presumed to be collected in any one year from the Tyth of the said Parish". The property had its own road from the High Street, but in 1814 Rev. Phelps built a new rectory, which is the one which survived until 1970, albeit with additions made by Canon Carey (see below):

Rev. Carey: I came to reside Oct. 17, 1865. The Parsonage at this time was inadequate to my wants, an attenuated-looking house, with two rooms, one on either side [of] the Porch, looking East, and three bed rooms over, two looking East, and one looking North: also three attics, one over each bedroom. Behind the dining room was the kitchen and adjoining this, as at present, the back-kitchen.

This attenuated house was built by Mr. Phelps in 1814. It supplanted a Parsonage that stood near the Pond, described [as above] by Thomas Washer, Rector in 1724. Finding this accommodation insufficient I borrowed f700 from Queen Anne's Bounty; and Arthur Blomfield Esq., M.A., Architect, undertook the requisite alteration. The old Porch, facing East was taken away, and the East wall divided so as to form one side to each of two new rooms: the drawing room 24ft x 20ft, the dining room 20ft x 16ft. The o1d dining room was divided into a pantry and a corridor, and the window made to face north. The window of the old drawing room was made to face South, and that room became the Library. Over the two new rooms, two bedrooms and a dressing room were built, one bedroom of the same size as the dining room below it; the other bedroom and the dressing room ranging with the drawing room. The windows of the two bedrooms that formerly faced East were made to face one North and the other South. The third bedroom was left unaltered. The windows of the two atticcs which were over the two bedrooms just named were made to face as the rooms below them. The Kitchen and back-kitchen were left. unaltered, but a covered way and a water closet were built at the back of both. The stable buildings were altered, so as to form at their extremity furthest from the house, a coach house capable of holding two carriages; at the extremity nearest to the house a stable with three stalls; between the two, a harness room and short passage. Good windows were put in, and ventilators in the wall next the garden. The front which had been weatherboard, was now built of brick. A fowl house was built on the opposite side adjoining two old offices. A pond in the middle of the Stable yard was filled up with lime ashes and gravel. The whole back-yard was then divided by a pale fence from the front. approach. The improvements in the stable premises cost f55 additional, and were nearly paid for by the trees which were cut down in the winter of 1865-6 by Messrs White of Maidstone. These trees were mostly Lombardy poplars, the rest firs, and a few elms: value £51.

The alterations in the house were begun Oct. 10, 1865, and we entered into it completed April 1, 1866. A large cesspool situate 12 feet from the end of the coach house towards Mr. Wood's meadow receives all the sewage of the house. The rain pipes on the North side of the house fill a sunk rain water tank also on the same side: that on the South side runs into the well in the garden.

On arriving to take up my residence I was told that the trees which bounded the pasture adjoining Mr. Gorhams field and which Mr. Phelps had always considered to belong to the Benefice, were disputed by Mr. Gorham. This dispute was subsequently referred to the arbitration of Mr. John Parker of Cuxton, and the trees assigned some to Mr. Gorham and some to myself. (The agreement, signed by myself & Mr. Gorham, is with my papers.) I put up wire fencing in such a way as to mark the Boundary: the trees tarred by the tar of the wire on Mr. Gorham's side belong to me, those tarred on my-side to Mr. Gorham. An agreement signed by Mr. Gorham & myself is with my papers.

I was also told that the trees adjoining the avenue on its Western side were disputed by Mr. Wood, and this dispute was, after much trouble and annoyance, referred to the arbitration of Messrs Toolete and Cobb. Evidence was heard on oath Sep. 15, 1868, and two months were allowed for the decision of the arbitrators: the award Lo be ratified, if desired, by order of H. M. Court of Queen's Bench. At the end of October the award was published, but in consequence of Mr. Wood's backwardness in paying his share it was not taken up until March 1869, when 12 trees were found awarded to him, and on Easter Tuesday March 30 the felling of these trees began. I then put up a wire fence in place of the o1d deal fence. The award of the arbitrators is with the rest of my papers. I planted seven trees in place of those trees taken from me two sycamores and five limes.
