The Bull

Its prime position in the village means that a house on the site is likely from earliest times. But it is not until about 1700 that we have any evidence of owners and occupiers. A family named variously as COSTIN/COSTEN/CAWSTEN/CAUSTEN/COSEN owned it at the end of the seventeenth century: GEORGE COSTEN was raising a family from 1686 and was buried on 19 Feb 1705. He was then the owner and his will includes what was the Bull and 5 acres [(b) below]

Will of **George Costen** of Snodland, yeoman: 03-01-1704/5; proved 20-04-1705 to loving friends George Wray of Paddlesworth and John Carnell of Birling and their heirs:

The Lodge

The Lodge was built by Thomas Fletcher Waghorn around 1841-2 and it was his Snodland home until he died in 1850. Before that the Churchwardens' accounts show that by 1769 the land had been owned by a William Baker (died around 1785), who was an 'outdweller' and then his wife/widow between 1785 and 1804. Anthony Whiting owned it 1801-1837. Occupiers are noted as Thomas Knight (1815-35) and Thomas Castle (1836-1840)



In his last years Waghorn became heavily in debt when the Government failed to honour their promise to pay for his attempts to establish a faster route through Europe. He placed two advertisements in *The South Eastern Gazette* of 7 September 1847L:

Forty pictures (collected by Lieutenant Waghorn, R.N., in two visits at Rome) are now placed in the County Assembly Rooms, Maidstone. For inspection and sale, apply to Mr. Day, 23, High Street, Maidstone, from whom particulars may be known.

An Arab stud horse (imported from Egypt by Lieutenant Waghorn, R.N.) 6 years old, which has not yet been used. To be seen at Mr. Waghorn's Stables, Snodland.

Nevertheless, the auction following Waghorn's death shows he still lived in considerable comfort. The house was bought by the Maidstone firm of William Day (who clearly knew Waghorn by 1847) and was rented out by them for several years at £45 p.a. The property to be let comprised 'A pretty detached Residence containing large Dining Room, Breakfast Room, Drawing Room, Library, 5 Bedrooms, Water Closet, good kitchen and offices. Cellars, a back entrance with paved Court Yard, 4-stall stable, Coach House, Coachman's Rooms. Ornamental garden with handsome elevated Summer House commanding an extensive view of the surrounding countryside'. A plan to demolish the whole in 1950 and replace it with six terraced houses fortunately came to nothing and the house survives as a Care Home.

WILLIAM HENRY POYNDER (1821-1880) had lived at Holborough where his brother Thomas [II] had managed the cement works for his father Thomas [I], but they had to move after William Lee bought the works in 1843. He moved to Hilmarton and Calne, Wiltsshire (where the family had an estate). His valet and butler was WILLIAM LETCHFORD (bap. AS 26 Aug 1821, s. of William and Mary and he moved with his master to Wiltshire. Master and son both played in two cricket matches organised by Waghorn in 1842. CHARLES LETCHFORD was brother to William. WILHELMINA MILLICENT HUGGINS (1791-1863), wife of THOMAS HULKS HUGGINS (1775-1850), was also housekeeper to the Poynder family at Holborough and was also a midwife.

Thomas [II], brother of William Henry, died in 1856 and his will includes many bequests. One is for £10 for a mourning ring to 'the Rev. H Dampier Phelps of Snodland' and another for £200 'to my butler and valet William Lutchford commonly called James Lutchford'. This must be William Letchford, baptised at All Saints in 1821, a member of the Holborough family and who clearly was a valued servant. After Thomas [II]'s death he became butler to his son William Henry Poynder (1821-1880). In 1851 William Henry was living in Waghorn's house and the next year an advertisement shows him to be 'Lord of the Manor of Veles, alias Snodland' to whom the rents should be paid on 24 November. In 1857 his lease of Middle [Clements'] Farm expired, and in 1867 as Lord of the Manor he gave the ground to enlarge the churchyard at All 3 Saints. Thomas [I] had bought the village of Hillmarton, Wiltshire, in 1813, and it descended to his grandson Thomas Henry Allan Poynder (1814- 1873), who acquired the Hartham Hall estate. This descended to William Henry after THAP's death and explains why William Letchford was still serving the family in Wiltshire. The 1871 census shows that WHP, unmarried, lived in a small house with just Letchford and a cook as servants. He paid for a major restoration of the church and was buried at Hillmarton on 10 August 1880. There is a memorial window to him and to his sister Isabella.

An advertisement by William Day in *The Maidstone Journal and Kentish Advertiser* of 19 April 1853 suggests Waghorn's effects were still in the house then. His wife had presumably moved to Tunbridge Wells (where she died in 1857)



BENET'S PLACE

Benet's Place was a large house on the north side of the upper High Street and east of the Monk's Head. It was presumably built by and for Thomas Benet (fl.1427-61). In 1817 it was converted into five cottages for farm workers and was demolished around 1970. New houses are now on the site. Some of the census returns are difficult to interpret because they lack precise information about which houses are meant - with muddled sequences and no identification beyond 'High Street' or ;Constitution Hill'.





Pond Field (Tithe 368) and Tithe 262-3 were part of the Benet's Place estate and had been bought by George Gorham (1794-1861), who evidently sold them to John Roots, who began building on them. Roots went bankrupt in 1855 and the houses were completed by John Tomlin
