Robert, son of Benedict Amari and Eleanor, daughter of Yvo Potin, his wife, to St Mary, Chatham: 5d free rent which the canons of St Mary's church used to pay each year: 3d at Michaelmas for a tenement at Little Chatham which they bought of Matilda, daughter of William Potin; and 2d which the heirs of Arnold Tirlwyne used to pay for land in Little Chatham which their father bought of Matilda, daughter of William Potin (fine 3s.) Witness include William Potin. Gift in free alms, c.1230. [DRc T498]

ate FELD

John ate Feld: one of five men 'seized of the manor of Padelsworth and the advowsons mentioned therewith' in 1367 [Cal. Inq. Post mortem, XV, 1-7 Rich. II, No. 22]

BAKER [PISTORE]

Gilbert. Mentioned in grant of lands by Walter Bogehurst to Bishop of Rochester; son John also mentioned. [Thorpe, RR, 604]

1219: holds 3½ acres of land in Snodland - the right of Philip of Alling and his wife Emelina - they grant it to G.P and heirs.

John. Son of Gilbert - surrendered lands to Walter Bogehurst.

Henry. Archbishop Hubert [Thorpe, RR, 392] Witness to grant of lands: Richard Kardun (1288); son is **John** [Thorpe, RR, 393-4]

BOGHEHERST [BOGHURST]

Walter Bogheherst, son of **John** de Bogeherst granted lands (surrendered to W.B. by John Pistore (Baker), son of Gilbert Pistore) to Bishop of Rochester, but remained the tenant. [Thorpe, RR, 604]

John Botere of Snodland: tonsure: 17-3-1342 [RHH, 197]

acolyte: 7-3-1349 [RHH, 242]

CANON

Ralph Canoun, a witness to grant of land to Bishop of Rochester by John Ussher [1299].

Plaintiff, with wife **Alice**, in Fine against John Auncel of Bello Campo and William le Pade of Stoke, concerning lands in Snodelonde [1314] [Arch. Cant. XIII, 289] A witness to grants of lands by Bishop of Rochester to William de Herdefelde, June 1322.

In 1367 Roger Dygge, John ate Felde, James de Becham, Nicholas Heryng and William Topclyve 'were seized of the manor of Padelsworth, ... to hold at the will of the said **Richard** [Charles], who subsequently entered into the manor and demised it at farm to Thomas Rote for six years [in 1375] ... and so died seized of his demesne as of fee.'

Died 1 June 1377; buried at Addington, where there is a brass Will: 26 Jan 1376-7: heirs **Richard** (aged 18) and **John** (aged 10), sons of brother

Roger. To Richard those tenements held by knight's service; to John those of 'gavel tenure'. To wife **Alice** a third part of the manor, except 163 acres of land, meadow and pasture of 'gavelkind tenure, whereof in accordance with the custom of gavelkind she will have no dower because she married again after Richard's death [C.Rich.II, File 1(10): Calendar of Inquisitions post mortem, XV, 1-7 Richard II, Nos. 22 and 25]

CHESTERFIELD/CESTERFORD

Exchange between **Walter de Cesterford**, rector of Paddlesworth, and Roger Lovekyn, priest, rector of Cranford (London dioc.), by Commission, 7 Aug 1324. Same day: resignation of 'domini Walteri de Cesterford'. [RHH, I, 153]

CHETWOOD

Ralph de Chetwode holds 1 quarter [of a knight's fee] in Padelesworthe of William de Say. 1254.

NB: A Deed with seal in Maidstone Museum: dated 1285-6, in which Ralph de Chetwode exchanges lands in Paddlesworth with others in Hetchine/Hotchine [Hitchen], co. Bedford.

DIGGE/DYGGE

Edmund: Rector of Woolwich 19 Dec 1335

Rector of Chislehurst 25 Feb 1336

Rector of Snodland 1337-8: 3 June 1337: Collation and Institution of Master Edmund Dygge de Berham to Rector of Snodland, vacant by the resignation of Thomas de Hethe. [RHH, I, 573]

DRAUEK

26 March 1328. Institution of Sir **Henry Drauek**, priest, to Padelseworthe. [RHH, I, 183]

18 Dec 1349. Institution of John de la Warde to Padeleswourthe, rector, void by the death of **Henry [Drauek].** Patron Sir John de Huntyngfeld. Mandate for the induction to the archdeacon of Rochester. [RHH, II, 900]

DRYLAND

Gwynand alias Wynand de Dryland. [NB a Faversham family of this name: Arch. Cant. XIV, 200]

8 July 1295. A witness to a charter from the rector of Cuxton, William de Handlo, confirming the payment of 10s annually to St Mary's Hospital, Strood [RHH, I, 7; Thorpe, RR, 260]

Accused of poisoning judge itinerant, Solomon de Rochester [Arch. Cant. V, 25]. Charged with the murder, but pleading his Orders, he was successfully claimed by the Bishop as a clerk. Finally he purged himself at Greenwich and was liberated. [Arch. Cant. LIII, 41-2]

Thomas Duntefrenche, a tenant of 1 acre in a field called Rifshet. [RHH] [see **Dounserrensh**?]

John de Eastwud, Rector of Snodland, 1274.

ELLIOT [ELYOT]

8 May 1368. [Pardon] to **Adam Elyot** of Snodelond of his outlawry in the county of Kent for non-appearance before Ralph Spygurnel and his fellows, justices of oyer and terminer in that county, to answer the king touching diverse trespasses, forstalleries and regrateries whereof he is indicted; he having now surrendered to prison before the said justices as the said Robert [Ralph] hath certified. [Cal. Patent Rolls, 1367-70].

William, son of **William**, was tenant of 2 acres of land in Snodland owned by Robert Vitulus, which R.V. surrendered to the monks/bishop of Rochester [Lbl, Cotton A.X.9, f.160v]

GARWYNTON

12 July 1349. Collation and institution of **Robert Garwynton**, priest, to Snodland, rector, void by the death of William Middelton. [From Wouldham]. [RHH, II, 882] 29 January 1355. Presentation of **Robert de Garwynton**, parson of the church of Snodeland, to the church of La Rye (Chichester dioc.), on an exchange of benefices with Master John de Kenyngton. [Cal. Patent Rolls, 1354-8; by privy seal.]

GLANVILLE

16 March/17 April 1348. Institution of **Thomas Glanvyle**, priest, to Dode rectory. Patron: Joan, late wife of Walter de Huntyngfeld, knight. Oath of obedience. Chapel of Trottiscliffe manor.

6 March 1350. Exchange of benefices between Walter Marscal, rector of Newick (co. Sussex) and **Thomas Glanvyle**, rector of Dode. [RHH, 902-3]

HATTERE

23 April 1391. Fine. **Peter Hattere** acquires from Thomas Pole and Christina his wife a messuage and 120 acres of land in Halling, Snodland and Cuxton [British Library, Add. Charter 36652]

HEMER

1271. **Robert** Hemer held messuage and 5 acres of William Potyn. Is son of **Benedict**. Wife is **Eleanor**.

HERDEFELDE

15 June 1322. Hamo, Bishop of Rochester, lets to farm to **William de Herdefelde** and his heirs, 7 acres of land in a field called Rifshet in Snodelonde at an annual rent of 7 quarters of barley, worth 4d. a quarter. [William also has 16 acres in Snodelonde and 16 acres in East Malling, which are to come under the jurisdiction of the Bishop. [Thorpe: RR]
